Asia Pacific Data Centre – Rejection of the Offers

NEXTDC Limited (ASX: NXT) (“NEXTDC” or “the Company”) refers to Asia Pacific Data Centre Group (ASX: AJD or “APDC”) ASX announcement, dated 28 December 2017 titled ‘APDC Offers NEXTDC Sale of Portfolio at \$300 Million’ and NEXTDC’s earlier ASX announcement today on the same topic.

Through NEXTDC’s legal advisers, Herbert Smith Freehills, the Company is now in receipt of summary versions of first right of refusal notices in relation to the portfolio of APDC data centres, including:

- Sydney (S1) at \$130 million (plus GST)
- Melbourne (M1) at \$110 million (plus GST); and
- Perth (S1) at \$60 million (plus GST) (collectively the “Offers”).

NEXTDC intends to formally **reject** each of the Offers under the first right of refusal notice on the grounds of unjustifiable value promoted by the 360 Capital-appointed Board of APDC.

NEXTDC’s action to wind-up the APDC Trust is scheduled for 31 January 2018.
